# 1. THE PURPOSE OF A FUNDRAISING PLAN

Fundraising is one of the most difficult problems that non-profit organisations, and especially universities, face. It takes time, a good strategy, planning and consistency to find funds for specific goals and to develop an organisation – especially in today's difficult funding climate.

A well-constructed fundraising plan is the first step to reviewing and defining goals, tactics and timeframes of fundraising activities. The consistent and systematic plan of actions will allow to meet or exceed your funding goals.

Creating a fundraising strategy is also a good time to determine the best fundraising options for your organisation, as there are many ways to raise money. Choosing the best options allows to focus on the most effective ways to raise money.

This document was created to define the elements of a fundraising plan and to provide tips for a successful fundraising plan for the intended International Doctoral Research Networks in the T4EU alliance.

The Doctoral Research Networks' goal is to deliver doctoral programmes through partnerships with organisations representing various business sectors in Europe and beyond in order to train the highly qualified young researchers, stimulate their creativity, enhance their ability to think innovatively, and boost their long-term employability.

As previously mentioned, the Doctoral Research Networks achieve their goals through partnerships of universities with research institutes, companies and other socio-economic stakeholders from different countries across Europe and beyond. These goals address the specific needs in various areas of research and innovation, bring academia into direct contact with the business sector, and enable the transfer of skills and competencies relevant to innovation. In addition to the standard Doctoral Research Networks, two types of doctoral programmes are particularly promoted:

**The Professional Doctorates** – designed to train doctoral students who want to develop and take their first step outside the academia in the industry or business. The doctoral studies will be supervised jointly by academic and non-academic partners.

**The Joint Doctorates** – a type of doctoral training with an international, cross-sectoral and interdisciplinary cooperation scheme. Doctoral studies are conducted according to a unified programme and supervised jointly by the participating institutions.

# 2. THE ANATOMY OF A SUCCESSFUL FUNDRAISING STRATEGY

#### A. THE FUNDRAISING PLAN

It is worth investing some time to prepare a solid plan for raising funds. It will help to avoid many problems in the future at the stage of implementation of the plan. Here are some points to consider:

1. The team – create a group of people that will help gather the information that is vital for understanding your university's needs.

2. The assets - identify your organisation's assets, so you can explain how potential money relates to the university's mission. Know what you have, and in what direction the university is going so you can present the university community impact to the potential funders.

3. The history – be familiar with the history and past fundraising practices of your university. This will show you what sources were used most often and help you to better estimate what actions to take in the future.

4. The money – before approaching potential donors, you need to know how much money you need.

5. A forecast - Get an idea of how much money you can raise and from what sources. Identify potential funders and make a list of what amounts you will be asking for.

6. Outline of activities – outline your strategy for achieving your goal. While defining the activities, try to make them as detailed as possible. The outline will act as a guide during your work on fundraising.

7. A schedule – create a timeline for the implementation of the plan. Put the fundraising plan on a timeline and set deadlines for the activities.

8. The plan – combine all activities into a fundraising plan.

#### **B. CHOOSING THE RIGHT STRATEGY**

Once the needs and the fundraising objectives have been established, a strategy should be developed for the most effective way to raise funds. In the case of raising money for international doctoral research networks, two methods should be considered in particular: public and private grant funding. Before choosing the right method, it is necessary to analyse the advantages and disadvantages of each potential funding source.

#### • PUBLIC GRANT FUNDING

Advantages	Disadvantages
1. Public funding can help you raise more money.	1. You need to do time-consuming research on the granting agency before writing the grant.
2. Once you have obtained one grant, it is easier to apply for other grants.	2. Competition is fierce, and the success rate is low.

# 4. THE ALLIANCE FUNDRAISING STRATEGY FOR THE INTERNATIONAL DOCTORAL RESEARCH NETWORKS

#### A. OBJECTIVES

The primary objectives of this fundraising campaign plan are as follows:

- To raise awareness of the importance of implementation of THE INTERNATIONAL DOCTORAL RESEARCH NETWORKS programme by partnerships of organisations from different business sectors with T4EU alliance universities.
- 2. To raise funds in order to train the highly skilled doctoral candidates.

#### **B. THE PROJECT**

Universities in the T4EU alliance will be launching a six-month long fundraising campaign. The purpose of the fundraising campaign is to raise enough funds to run the International

Doctoral Research Network programme for at least two doctoral students at each of the T4EU alliance's universities.

#### C. THE SCOPE OF ACTIVITIES

The project will consist of two phases: A) Preparation and B) Execution, Monitoring and Completion phase.

#### D. METHODOLOGY

The T4ERI fundraising group (TFG) will work closely with the alliance partners, local authorities and business stakeholders. This plan will outline the strategies, timeline, action plan and budget allocated to pursue the goals of the campaign.

### F. THE TEAM

To facilitate the process of raising money, we will ask each university to nominate two people who will perform the following roles:

- 1. **Programme Director** the person who will ensure that the plan is implemented accordingly to the arrangements.
- 2. **Communications Officer** the person who will coordinate communication with all the stakeholders and give updates to the media.

#### I. FINAL REMARKS

The primary source of funding of the activities of a public university are subsidies from the state budget for the tasks defined by law, as well as the university's own revenues (e.g., in the form of donations, revenues from research services, rental of space, commercial educational services, but also sponsorship agreements). Nowadays, universities face a new challenges of a proefficiency funding system that will encourage universities to allocate more resources to research and development. These forces are more flexible in the allocation of subvention funds and provide an opportunity for universities to develop activities related to the commercialization of the high-quality R&D results, but also to conduct the systematic fundraising activities.

The business environment is eager to make donations wishing to obtain an image of being socially responsible and not being focused on profit but identifies certain activities mostly with their brand identity. The universities can serve as a strategic partner for companies in training graduates for the needs of, in particular the industry, and in this way try to obtain the funds for various types of additional programms for students and graduates (training and courses conducted by industry specialists, professional mentoring, support for academic entrepreneurships, thesis competitions, student/doctoral scholarships, offering paid internships or jobs to the best graduates). Unfortunately, these days it is becoming noticeable that the business community's interest in sponsoring scientific research is declining. Most likely it is the result of the prolonged inflation and the ongoing war in Ukraine.

Undoubtedly, the successful fundraising activities require not only a long term planning and preparation of a strategy, but also the involvement of an adequate number of personnel cooperating with the various university units, as well as with the business community.

This document has been prepared as fundraising tool for obtaining national as well as European funds. However, most preferable would be raising funds and engaging the private sector. Despite the many benefits, unfortunately cooperation between universities and businesses is not often established. We hope that developed strategy will change this situation and will allow for effective fundraising as well as establishing cooperation with the business.
