2. Executive summary

The T4EU Joint Strategy on Microcredentials (MC) outlines the main elements for elaborating T4EU MC offerings until 2030. It is developed to ensure that the joint T4EU Alliance MC courses/programmes are in line with the 10 EU-adopted principles of Quality, Transparency, Relevance, Valid assessment, Learning Pathways, Recognition, Portable, Learner-centred, Authentic, Information and guidance.¹

The specific principles to follow include respecting existing (where available) national legal requirements as well as respecting the specific institutional, regional and national contexts of the T4EU partner universities and consideration of the various learners' needs.

Target learner audiences range from school leavers through university students to lifelong learning participants, making it beneficial for upskilling and reskilling current workers. Thus, microcredentials cater to the evolving needs of the workforce, aligning with trends in continuous professional development.

Hence T4EU Microcredentials courses/programmes shall offer variety and flexibility in terms of format, duration and mode of delivery based on real needs.

The Joint Strategy on Microcredentials (MC) is based on the agreed definition of Microcredentials below. The Strategy is accompanied by a Joint T4EU Framework on Microcredentials, which provides clear conceptual guidance to ensure that the Transform4Europe Alliance has the tools to become a leader in this area. The two documents should be regarded mutually complementary and revealing the Alliance vision with regard to Microcredentials.

Apart from the task force group, the T4EU Steering Committee, the Joint Quality Assurance Office, the Joint Communication Office and the Joint Mobility Office, relevant university structures, i.e. departments dealing with lifelong learning, post-graduate education, Erasmus offices, etc. will be consulted when offering T4EU MC courses.

3. Goals

In keeping with the principles outlined above, the Joint Strategy on Micro-Credentials 2030, outlines the hierarchy of goals and measures to be pursued by the T4EU Alliance namely:

- creating a portfolio of joint flexible microcredentials offer
- opening at least 25 microcredential courses by the end of 2027 including existing and newly developed ones
- establishing a sustainable mechanism for adapting and developing T4EU microcredentials offer beyond 2027.

4. Joint T4EU definition of microcredentials

The T4EU Alliance adopts the following definition on microcredentials.

Microcredential (MC) means the record of the learning outcomes that a learner has acquired following a small volume of learning within a degree or a lifelong learning programme that takes into account the needs of the European labor market and responds to new and emerging societal needs. They lead to acquiring an additional specialisation or professional competence and/or provide added value to a degree but do not represent a degree as such.

MCs are owned by the learner; they can be shared; they are stackable and are portable⁴. They may be stand-alone or combined into larger sets of credentials. They may lead to certification and/or to awarding a certain number of ECTS credit points, i.e. 1, 1.5, 2, etc. up to 30 (depending on university). These high-potential training offers are distinguished by their ability to be combined (stacked).

Learning experiences leading to microcredentials are designed to provide the learner with specific knowledge, skills and competences that respond to societal, personal, cultural or labour market needs. Microcredentials learning outcomes are assessed against transparent and clearly defined criteria. They are underpinned by quality assurance following agreed standards in the relevant sector or area of activity ensuring their quality, transparency, cross-border comparability, recognition and portability.
